## June 15, 2009 Argyle Village Board Meeting

Meeting opened 5:32 P.M.

Mayor Ellithorpe spoke to DA. Regarding Wilson dog issue

- -an ACOD filed against Wilson
- -Town, Holland, and Village are to be reimbursed monies owed
- -a release was signed so that the dogs could be adopted

Trustee Lohret made motion for a resolution allowing Clerk to pay the contractors and Marvin & Co. when monies become available; Mayor seconded; all voted in favor of. Two homes have been finished and the owners are very happy. A total of ten homes were approved for the project.

- -there is a buyer for the property at 49 Sheridan Street
- -there may be a buyer for 20 Elm Street as well
- -Randy Cuthbert had to replace a meter at one of the wells

Mayor gave Board update on Sewer Project:

- -went to Congressman Murphy's office and presented problems in Village;
  - -will work so Village keeps \$500,000 already approved for
- -Anthony Jordan's office sent letter of recommendation
- -Village may be able to get money in round two of disbursements

Board approve a budget transfer to cover cost of web site:

- -\$1,000 from sidewalks
- -take money from celebrations
  - -port-a john only for July and October
- -to set up web site \$1,072.00
- -\$600.00 for static site
- -\$107.00 for link
- -\$100.00 for deposit
