

## **September 6, 2010 Village Board Meeting**

Those in attendance: Mayor Wesley Clark; Trustees, Joe Lohret, Cher McCotter, Peter Bailey, and Joanne McDowell; Clerk Joyann Stimpson; and Water Commissioner Garry Robinson.

Meeting called to order at 5:30 P.M.

Water Commissioner Robinson gave his report on the water main leak at the Hardware Store on Main Street August 1, 2010

- break found to be an old line going to what used to operate a generator to power streetlights
- once break was found parts were located and contractors were able to fix relatively quickly
- more people need to be put on call list to notify of water shut-off firehouse and rescue squad
- DOT helped with cones
- boil water notices were handed out but some residents did not get notice
- hand notices were not done for the rescind of boil water
- DOH wants Village to think about putting shut-off valves among lines so not whole Village is without water during repairs
- hole in front of old fire house on Main Street was repaired by Randy Cuthbert and Larry Ashcroft

### **ACET**

Trustee McDowell stated the group wanted to come to Board meeting but was just not possible. The group wanted to know about putting in gardens on the ten acres behind the Stiles' house but is unable to because they can only use land directly around the Stiles' house.

Mayor stated that next Board meeting will also to be a public hearing because the franchise agreement with Time Warner is up for renewal. Mayor Clark was asked at this time to see what could be done about getting internet at the Village office.

Trustee McCotter made motion to accept Minutes for month of July, 2010 as read; Trustee Lohret seconded; all voted in favor of; motion carried.

Trustee McDowell made motion to allow Clerk to pay bills for month of September, 2010; Trustee McCotter seconded; all voted in favor of; motion carried.

Mayor stated that he has sorted through many of the Village records and wants to ask Sue Brennan to see if they have any archival value.

Trustee Lohret asked how many more meetings would the Village be holding at the Stiles' House and was told because of the need for a public hearing it would be held one more time there before winter.

Trustee McDowell wants the Village Board to have better communication with the Stiles' Committee. The Board has asked that Chris Castrio come to the October Village Board meeting.

The Stiles' Committee is planning two events for the month of October; a car show and its annual haunted house and will need a resolution for insurances for these events.

Mayor stated that Randy Cuthbert needs to shut water off at the apartment house owned by David Willis on Main Street, Argyle.

Mayor spoke to Marvin & Co. and was told that the State has not been giving out any grant monies at this time but said the Village would receive monies when the State released funds.

Trustee Lohret made motion to close meeting; Trustee McDowell seconded; all voted in favor of; motion carried.
