December 13, 2021 Argyle Village Meeting

Those in attendance: Mayor Wesley Clark; Trustees Joy MacKenzie; Anthony Montello; Clerk Joyann Stimpson; Sarah Huggins. Attending through Zoom Trustee Cher McCotter; Glenn Bristol; and Joanne McDowell.

Meeting called to order 5:34 P.M.

Ms. Huggins reported to the Board that 7 streetlights had been replaced through the Village. She had a conversation with the lineman who was replacing one of the lights and he brought up that National Grid could replace the old lights with led lights and save the Village money. Ms. Huggins stated the New York Power Authority would cover some of the cost. Ms. Huggins also informed the Board that Karen Lohret would be able to show the old IGA building if anyone would like a walk through of the building, She also informed Board that there is asbestos in the building.

Mayor Clark informed the Board that he had drafted a letter to Mary Ann Cherry regarding her issue with Led lights. Trustee MacKenzie volunteered to research the affect of LED lights and epilepsy patients.

Mark Dennison is resigning from his role in the water department and Water Commissioner Robinson is looking for his replacement.

Mayor Clark participated in the Flood Plan Webex. The Federal Government has specific requirements in a flood plain.

Mayor Clark informed the Board on the Salem Sewer Project.

- -Supervisor Sue Clary said the Delware Engineering Firm has been working with them for 3 years
- -so far they have completed an income survey and a feasibility study

The Village has a Sewer Committee comprised of Trustee MacKenzie and her husband Jonathan,

Carol Kuhr, Glenn Bristol, and Scott Lufkin

Mayor Clark informed Board that he and Water Commissioner Robinson had a conference call with the EFC, Engineer Katlin Perner and Director Mike Hale. They were told that the EFC has \$428 million of federal dollars to use for replacement of lead pipes and toward sewer and water system improvements.

Lake George Lake Champlain Regional Planning Board wants a committee to work on a source protection program which Faith St. John and Sarah Huggins are a part of.

The village will request an extension for well 7 to be completed by May1, 2022.

On a motion made by Trustee Montello, seconded by Trustee MacKenzie, and carried, the minutes of the November 1, 2021 meeting were accepted as written.

On a motion made by Trustee McCotter, seconded by Trustee MacKenzie, and carried, the Clerk was allowed to pay warrants for the month of December.
