

## **April 5, 2010 argyle village board meeting**

Those in attendance: Mayor Wes Clark; Trustees Joseph Lohret, Cher McCotter, and Joanne McDowell; Clerk Joyann Stimpson; and Robert Wyman.

Meeting called to order at 5:31 P.M.

Newly elected officers signed record book for oath of office; Wes Clark as Mayor; Cher McCotter as Trustee; Peter Bailey as Trustee signed in before he went on vacation.

Robert Wyman is looking for Village to grant peddlers license.

- employee wants to use old IGA parking lot to set up vender cart for hot dogs
- daytime hours Monday thru Friday 11:30 A.M. until 2:00 P.M.  
unless events in evening
- certified with DOH license
- Attorney Radner needs to advise on legalities of

- steam table and grill
- used paper to wrap
- starting in May
- \$10.00 for year for license

Trustee Lohret made motion to allow license; Trustee McCotter seconded; three Board members voted yes; Trustee McDowell abstained do to conflict of interest because her affiliation with Stewart's Corporation; motion carried

Mr. Wyman paid peddlers fee plus \$10.00 donation to Stiles house and left at 5:47 P.M.

Commissioner Robinson gave water report

- well#1 chlorinator shut down and replaced; recommended we have
- must have two working at all times
- ordered pressure gage to figure out why pump blown in well 5
- DOH want more testing done before chlorinating
- leak in pipeline may be causing positive test
- each well needs to be tested
- plenty of water
- Garry to talk to person at PVI who maintains pump house at Summit Lake

Sewer

- application not in formant that Rural Water wants so must redo it
- archeological study must be done; may cost up to \$10,000; Mayor gave Commissioner Robinson the go ahead to get bids
- HCR may grant utility grant
- need to have 37% low-moderate income; income survey needs to be done
- not able to get monies this year

Commissioner Robinson had meeting with EJP about problems regarding non-payment of their bills

- listed all that we do not have
- received wrong materials
- need to distance form further business with EJP

Board members signed resolution for Harold Adams for his years of service.

Mayor presented Board with committee appointments; Marcus Butterfield to be Deputy Clerk for Village.

Mayor asked Board members to be consider what will be included in 2010-2011 budget

- replacement of flags
- cost of moving to Stiles' House
  - heat
  - office equipment

Alarms for water tank need to be moved from Municipal building.

Minutes from March meeting were accepted as written with a clarification that the Village is not responsible for putting up sign for Lufkin Commons; Trustee Lohret made motion to accept minutes; Trustee McCotter seconded; motion carried.

Trustee McDowell made motion to allow Clerk to pay warrants for month of April; Trustee McCotter seconded; motion carried.
